It is mutually agreed that the following terms of the agreement form an integral part of this contract and that no variation or modification of this contract shall be effective unless accepted by the photographers in writing.

Booking fee - a booking fee as per the deposit amount stated overleaf is charged when the client signs this contract. The balance of the fee shall be paid no less than 30 days prior to the wedding date. If the option to pay by monthly standing order is taken, a minimum of six payments, in addition to the deposit, must be made prior to the wedding and a maximum of 12 payments may be made after the wedding without incurring additional cost.

Photographs - All stated photograph sizes are nominal. The photographers will provide a pleasing colour balance but cannot guaranteed exact colour / contrast matching. Owing to anomalous reflectance caused by a combination of certain dyes and materials, it is sometimes impossible to record on film and light sensing microchips, the exact detail as seen by the human eye.

Copyright - The 1988 copyright act assigns copyright to the photographer. It is contrary to the act to copy or to allow to be copied, any photograph or digital material covered by this contract. Contradiction of the copyright act 1988 may result in prosecution.

Model release / license to reproduce - the client agrees to grant the photographers absolute rights to use the photographic images for any form of reproduction including display and promotional purposes by the photographers, advertising, press, editorial or for licensing to third party's for reproduction in any form or media. The clients agrees that all third party's invited to attend the wedding shall be made aware that images may be licensed for full library / reproduction usage, and may be made available for promotion and reproduction via the internet. The clients assign all moral rights to any images taken on the wedding day to the photographers.

License - the photographers shall be granted artistic license in relation to the poses and the location used. The photographers judgments regarding location, poses and number of photographs taken shall be deemed correct.

Force Majeure - The due performance of this contract is subject to alteration or cancellation by the photographers owing to any cause beyond their control. In the unlikely event of total photographic failure or cancellation of this contract by the photographers, liability shall be limited to a full refund of all monies paid.

Cancellation - In the event that the client cancels this contract at any time by giving written notice, the booking fee shall be forfeited. In addition, if notice of cancellation be received by the photographers less than 12 weeks prior to the wedding, the clients shall pay the photographers a sum equal to 50% of the total photography fee. The said sum being compensation for the amount of loss that the photographers would suffer.

Negatives and digital files - photographs are kept on active file for six months after the wedding and shall be available for reprints in accordance with the photographers reprint prices at time of order. After six months a minimum order value of £50 will apply. All negatives and images remain the intellectual property of the photographer and shall be kept by him for not less than 10 years. Clients may apply for a copy of any image at any time in accordance with the photographers prices in force at such time.

Use of images - the clients agree that they shall not reproduce or offer for reproduction any photograph covered by this agreement in accordance with the copyright act 1988. Digital images must not be copied or transmitted by digital means unless for personal use.

We have read and undertake to abide by the schedule and terms of the agreement in this contract.
